## Re: Request under the Freedom of Information and Protection of Privacy Act

British Columbia Ferry Services Inc. (BC Ferries) received your request for access to records under the *Freedom of Information and Protection of Privacy Act* (the FOIPP Act) on August 29, 2022. Your request was as follows:

"For the Baynes Sound Connector:

1. Details of the business case (or similar evaluation) including Financial Forecasts, Operational Performance Forecasts, Sustainability Performance Forecasts and any other information which supported the business case;

2. Include similar details for all comparable options (traditional ferries) evaluated during the selection process and criteria for the selection the Cable Ferry as the preferred option; and

*3. Financial, Operational and Sustainability reports from inception of service in 2015 to August 26, 2022 for all indicators compared to the original business case."*
