Re: Request under the *Freedom of Information and Protection of Privacy Act*

British Columbia Ferry Services Inc. (BC Ferries) received your request for access to records under the *Freedom of Information and Protection of Privacy Act* (the FOIPP Act) on August 16, 2023. Your request was as follows:

"Any and all records (emails, sent or received including attachments; and documents such as issues notes, briefing notes, summary notes, progress reports, meeting agenda, meeting minutes/notes or memorandums) regarding a meeting attended by Premier David Eby and BC Ferries senior leadership team on July 28, 2023 (date range of records search: July 21, 2023 to July 28, 2023)."

Enclosed please find copies of the records responsive to your request. Some of the records contain information excepted from disclosure under the FOIPP Act. This information was severed so the remaining information could be disclosed. The severed information is excepted from disclosure under sections 15 (harm to the security of a system), 19 (harm to public safety) and 22 (personal information) of the FOIPP Act. We have noted on the records disclosed to you the sections of the FOIPP Act we relied on to sever the information.
