<u>Note:</u> If you choose to pre-clear your DG documentation, the strict application of the *time limit* (45 minutes prior to sailing time for major terminals and 30 minutes prior to sailing time for minor terminals) may be waived, providing the document accompanying the shipment is identical to the document submitted for pre-clearance.
